Methodology

The survey findings presented in this release are based on the results of interviews conducted September 15-21, 2009. The interviews were conducted at the Center for Opinion Research at Franklin and Marshall College under the direction of the poll's Director Dr. G. Terry Madonna, Head Methodologist Berwood Yost, and Project Manager Jennifer Harding. The data included in this release represent the responses of 1,046 adults in the United States, and 900 of them are registered to vote. Telephone numbers for the survey were generated using random digit dialing, and respondents were randomly selected from within each household. Survey results were weighted (age, education, race, region, and gender) using an iterative weighting algorithm.

The sample error for this survey is +/- 3.0 percentage points. The sample error for registered adults is +/- 3.3 percentage points. In addition to sampling error, this poll is also subject to other sources of non-sampling error. Generally speaking, two sources of error concern researchers most. Non-response bias is created when selected participants either choose not to participate in the survey or are unavailable for interviewing. Response errors are the product of the question and answer process. Surveys that rely on self-reported behaviors and attitudes are susceptible to biases related to the way respondents process and respond to survey questions.

This release is the first in a series that will present the findings from the September 2009 National Franklin & Marshall College Poll.

Key Findings


The most recent National Franklin and Marshall College Poll finds a majority of adults reporting the economy and personal finances (50%) as the most important problems their families currently face, with healthcare-related issues a distant second (19%). For both economic and healthcare issues, a majority of adults believes the problems faced by their families can be solved with the help of the government; 57% of those with financial concerns believe this, and 68% of those with healthcare issues believe it.

Healthcare

Americans are divided about how well the United States' healthcare system compares to the systems in other industrialized countries. About one in three (36%) believe the U.S. system is above average, while similar proportions believe it is average (29%), or below average (30%). Still, respondents are generally satisfied with how well the current healthcare system meets their needs. More than one in three (35%) say the system meets their needs very well, and another two in five (43%) say it meets their needs pretty well, leaving about one in five (21%) Americans who feel the system is not serving their personal needs. Women, those under 54 years of age, Blacks, and registered Democrats are least likely among sex, age, race, and party registration groups to believe the system does not meet their needs (see Table A-1). Three in four (75%) Americans who have health insurance currently rate their coverage as very good or good.

The cost of healthcare and availability of health insurance coverage were significant problems for many adults during the past year. Nearly one in four adults report skipping a recommended test or medical treatment because of the cost, and one in four did not fill a prescription medicine because of the cost (see Figure 1). About one in five respondents say they were without health insurance coverage at some point during the previous 12 months.

Presidential Performance

Half (51%) of registered Americans believe that President Obama is doing an excellent or good job as president. The president's job performance ratings differ considerably among demographic groups, and he fares most poorly, not surprisingly, among Republicans (see Table A-2). More registered Americans believe the president has better ideas for reforming healthcare (47%) than do the Republicans in Congress (21%), but a third (32%) do not know who has the better ideas.

More than half (51%) of registered Americans approve of the way President Obama is handling the situation in Afghanistan, and about the same proportion (54%) personally favor the military operations taking place in that country.
